## **Checklist & Questionnaire**

Please use the enclosed checklist and new questionnaire to facilitate accurate return preparation and to designate a primary contact person and preferred method of contact.

#### **Avoid Penalties, Pay Estimated Tax**

Make quarterly installments to prevent under-withholding penalties. You may incur these penalties if you owe the IRS over \$1000 or owe Missouri over \$500.

#### **Create an IRS Account**

Go to IRS.gov/account to create a personal account. The verification process is easy to complete.

Find information on Child Tax credit, Stimulus Payments, Tax Balances, Transcripts, Payment History, Payment plan details, and get an IRS PIN, and more.

## **Gift Reporting**

Let us know if you made or plan to make a large cash gift of over \$15,000. We will file the required information reporting forms.

#### **Avoid Refund Delays**

Federal return processing will be delayed if your figures do not exactly match the IRS records for:

- 3<sup>rd</sup> Economic Stimulus The maximum payment was \$1400 per person on your tax return.
- Advance Child Tax Credit These payments were made from July 2021 to December 2021 to clients with qualifying children.

## Medicare Benefits start at age 65

If you decide to delay your Social Security benefits until after age 65, you should still apply for Medicare benefits within three months of your 65th birthday. If you wait longer, your Medicare medical insurance (Part B) and prescription drug coverage (Part D) may cost you more money.
